## **4 Work in Progress**

- 4.1 A final phase of the Drift Trials has been completed and the results are being written up. This will provide evidence that will allow a review to take place of the width of the aerial buffer zone against surface water bodies.
- 4.2 Some initial discussions have taken place with SAC about the carbon impact of bracken, and the effects of any control.
- 4.3 A review of knowledge gaps is in progress that builds on the list included in the James Hutton Institute's report to the Scottish Government.
- 4.4 Discussion is taking place with Serco about the feasibility of mapping bracken and areas of control using satellite imagery.

## **6 2023 Bracken Control Season**

- 6.1 The late decisions about asulam did not help anyone.
- 6.2 The approval for the use of asulam in England was welcomed, but the refusal in Scotland, Wales and Northern Ireland was disappointing.
- 6.3 An aerial spraying programme was carried out in England and helped by the uplift in funding available through Countryside Stewardship.
- 6.4 In England, anyone holding unopened containers of Asulox has until 27<sup>th</sup> October to return them to their distributor for a refund. It will be illegal to retain any stocks of Asulox after this date.
- 6.5 Records of all use of Asulam in 2023 are required to support the application for the 2024 season. The record forms are available from the website in various formats in the hope that one of the formats will suit everyone.

## **7 Emergency Authorisation 2024**

- 7.1 Despite efforts to find an alternative way forward, if asulam is to be available anywhere in the UK for the 2024 bracken control season, the only way to achieve this is through another emergency authorisation.
- 7.2 Feedback from practitioners / case studies are being considered as a way to present views about bracken and its control to support the application. A questionnaire could be used to capture the information.
- 7.3 Several letters of support were included with the application for the 2023 season. Similar letters will be welcome to support the 2024 application, and these will provide an opportunity to make points about the use of asulam on behalf of different sectors.

## **8 Scottish Government Stakeholder Roundtable meeting**

- 8.1 This meeting was held in response to the public exchanges<sup>3</sup> that occurred about the delayed decision on the asulam application and then the refusal.
- 8.2 The Minutes from the Roundtable meeting are available on the Meetings page of the website<sup>4</sup> with the feedback provided on behalf of the BCG.
- 8.3 The key outcomes were:
  - 8.3.1 Establishment of a small working group to continue engagement and lead on next steps including further evidence gathering.
  - 8.3.2 Agreement that new and improved practitioner guidance should be developed.
  - 8.3.3 The delay in issuing a decision to the asulam application in 2023 (and 2022?) was recognised and efforts would be made with HSE to avoid a repeat.
  - 8.3.4 The conservation agencies would work together to develop a UK Bracken Strategic Framework.
- 8.4 In subsequent discussions with Natural England, on behalf of the BCG, support has been offered for the working group and the development of the practitioner guidance. A meeting with Scottish Government and NatureScot is due shortly.
- 8.5 The reinstatement of funding for new bracken control programmes through the Agri-Environment Climate Scheme was flagged as a priority issue.

## **9 Feedback**

- 9.1 Suggestions for issues<sup>5</sup> to be covered as part of the emergency authorisation application will be welcome.
- 9.2 Any comments<sup>5</sup> on the contents of this newsletter will also be welcome.
